Since the issue of the CAR form, it has been found that the NRW system had an incorrect link from the sample point number associated with Glascoed WTW and the permit numbers i.e. Glascoed New and Glascoed Old discharges were associated with permits that were the wrong way round. This now means that the sample result of 0.18 mg/l is not for permit CG0349301 but for permit CM0062901. The result is compliant with the permit conditions.

The previous CAR form which recorded a breach is now void and the comments taken from this form below are also void.

NRW have rectified this error.

Result for Chlorine of 0.18 mg/l on 1st August 2019. Sample was taken and submitted by DCWW.

Permit limit for Total Chlorine is 0.05 mg/l.
