G1 Monitoring of Emissions and Environment/G4 Reporting and notification to Natural Resources Wales

Natural Resources Wales received a schedule 6 notification for the exceedance of emissions limits for surface and ground water at Rhuddlan Bach Quarry.

E2 Land and Groundwater

The Schedule 6 monitoring data shows the following trigger limits have been breached.

Borehole BH3B: has exceeded the limit for sulphate at 275 mg/l compared to the permitted limit of 250 mg/l and TPH at 0.016 mg/l compared to the permitted limit of 0.01 mg/l.

Borehole BH5: has exceeded the limit for TPH at 0.011 mg/l compared to the permitted limit of 0.01 mg/l.

This is a **category 3** permit breach with respect to permit condition **3.1.1** "There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 3 table S3.1." Groundwater emission limits are highlighted in Schedule 3 tables 3.2 and 3.6.

E3 Surface Water

Sampling at SW2: has shown an exceedance in the limit for TPH at 0.016 mg/l compared to the permitted limit of 0.01 mg/l.

This is a **category 3** permit breach with respect to permit condition **3.1.2**. "The limits for surface water quality specified in Schedule 3, table 3.5 shall not be exceeded.

A consolidated **category 3** score has been applied for these breaches.

Actions: Continue monthly monitoring and investigate any trends. If a breach in emission limits occurs in the next quarter, please submit a investigation plan to NRW.
