Annual Submissions & Q4 2019

Dawn Meats submitted its annual returns and Q4 on 27 January 2020. The percentage change is based on the 2018 data submitted by Dunbia (UK) Cross Hands.

Waste - Total waste figures have risen (11%) inline with Dunbia comments of the increase of production in 2019.

Energy – Energy consumption of Electricity has increased slightly (1%) whilst gas consumption has decreased (1%) over 2019. The overall picture shows an improvement in energy efficiency with total production having increased by 22%.

Product - Total production has increased by (22%) with raw meat and value added meat seeing increases (22% and 34% respectively) whilst cooked meat has seen a significant decrease (24%) in production. Since the permit was issued there has been a relatively steady production level around 26,000T.

Total potable water - This category has seen this largest improvement on 2018 results by decreasing around 32%.

Monitoring Summary for Quarter 4 – All reporting values are within the permit limitations as per table 2.2.2.7.
