Celtic Chemicals Ltd (CCL) is a privately owned company who carry out chemical dissolution and packaging; powders blending and repackaging; and storage and on-sale of chemicals. The permit was issued in 2007 as a 'low impact installation' (LII) and it is a requirement that CCL provides an annual report which provides evidence that they still meet the LII criteria.

CCL submitted its compliance with Low Impact Installation criteria assessment for 2019 on the 13th of February 2020.

Following assessment of the annual submission, the facility continues to operate under the criteria for Low Impact Installation with NRW welcoming the implementation of ISO14001 during 2020.
