Emissions to air

A2 and A3 are process stacks associated with the tin melting operation, but AMG has not generated steam from its boiler since April 2015 and therefore air emissions since 2016 have been reported as nil.

Emissions to water

W1 Q4 results have been recorded as 'n/s' (not sampled). This will need to be discussed at the next opportunity.

Groundwater monitoring

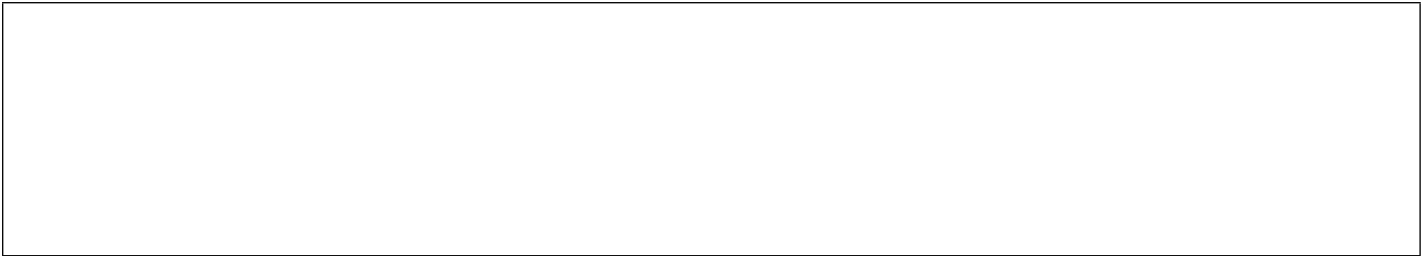
AMG has undertaken 6 monthly sampling of its boreholes G1-G7. Borehole G2 was classed as inaccessible on the second annual sampling regime due to demolition waste impeding access. Inspector expects this demolition material to be cleared in readiness for the next round of sampling.

Energy Usage

Annual energy consumption has been recorded as 421.304MWh of electricity. The electricity consumption for 2018 was recorded as 957.10MWh. This reduction in electricity usage is inline with the reduction in site operations.

Waste sent for disposal

No data submitted. Instead AMG has submitted the R1 form for waste arisings. Data has been provided for Magnetic separator wastes and used can contraries and polyethylene – 829.18 tonnes.
