Permit condition 6.1.1 requires that “a summary of waste types and quantities accepted and removed from site for each calendar year to be submitted to Natural Resources Wales in the form of waste returns. This should be done within 1 month following the end of that year. Annual Waste Returns for 2017, 2018 and 2019 have not been submitted.

On the 8th June 2017 a warning letter and EPR Regulation 36 notice were issued to Harris Salvage relating to missing waste returns for 2015 and 2016. Due to previous warnings and enforcement action in relation to this breach a **Category 3** CCS score has been applied. A warning letter is also embedded within this CAR form.

Actions: Submit missing waste returns for 2017, 2018 and 2019 by the 31st July 2020.
