CONDITIONS OF CONSENT

1. The discharge shall consist only of treated domestic sewage effluent from the sewage treatment plant, which consists of primary sedimentation, biological filtration and secondary sedimentation, serving a population of 250 or less and containing no authorised trade waste.
2. The discharge shall be made in the manner and at the place specified as follows:

Discharging via : a pipe
Discharging to : a sub-surface soakaway system
At OS Grid Ref : SN 0732 2919
3. The Company will operate the works such that:
 - a. it remains fully operational except at time of mechanical or electrical breakdown;
 - b. any such breakdowns shall be attended to promptly and the equipment returned to normal operation as soon as possible; and
 - c. tanks shall be desludged at sufficient frequency and in such a manner as to prevent problems with septic sludge, rising sludge or excessive carryover of suspended solids.

Application for Variation to Descriptive Consent

Please find enclosed the reviewed consent for Rosebush STW.

As there is no specified volume in the consent for charging purposes the works will fall into the volume band 20 - 100m³/d. This agrees with the volumes in the previous consent which were for 22.7m³/d DWF and 90.8m³ maximum daily flow. The contents factor will change, moving from band C at present (3.0) to band D (2.0).

I trust that the confusion and delays in determining this variation have now been finally resolved.

CONSENT VARIATION

I am directed by the Secretary of State for Wales to refer to the discharge consent in respect of the ROSEBUSH..... sewage treatment works dated 17. DECEMBER. 1982

The Secretary of State for Wales, having consulted with the Welsh Water Authority, hereby gives notice that in exercise of his powers under Regulation 7 of the Water Authorities (Control of Outlets and Discharges) Regulations 1975 (SI 1975 No 450), the conditions imposed on the said consent shall be varied in the following terms:

CONDITIONS

The quality and quantity of effluent shall not exceed the following maximum values:

Biochemical Oxygen Demand (+ ATU) over 5 days at 20°C;8.5..... milligrammes per litre.

Suspended Solids dried at 105°C;6.5..... milligrammes per litre.

Ammoniacal ammonia expressed as nitrogen milligrammes per litre.

Dry Weather Flow ~~litres per second~~ or ..22.7.. metres cubed per day.

Maximum rate of flow 1.06 litres per second a
90.8 metres cubed per day.

This variation takes effect from the ..30.. January 1985.

This Notification is issued under the above-mentioned Acts and Regulations and all other enabling powers as a CONSENT DEEMED TO HAVE BEEN GRANTED BY THE SECRETARY OF STATE FOR WALES and is in respect of : an Outlet and a Discharge of Sewage Effluent

from the Authority's : ROSEBUSH SEWAGE TREATMENT WORKS

The Authority submitted this Notification of Consent on : 17th September 1982 to the Secretary of State for Wales, in the form of a draft, and he has NOT, within three months, required the Authority to apply to him for a consent. This Consent has therefore taken effect as a consent which is deemed to have been granted by the Secretary of State for Wales, subject only to the following conditions, on : 17th December 1982

CONDITIONS

As to the OUTLET :

1. The form and location of the outlet shall be in accordance with the following, namely,
 - an outlet in the form of : the existing outlet
 - and discharging into the : un-named tributary of the Afon Syfynwy
 - at National Grid Reference : SN 0735 2918
 - and which is shown marked : Discharge Point
 - on the attached Plan No. : RW/0343/1/U1
2. The outlet shall be used only for making the discharge specified in Condition 3 below.

As to the DISCHARGE :

3. The discharge shall consist only of treated sewage effluent from the above works.
4. The quality and quantity of effluent shall not exceed the following maximum values:

Biochemical Oxygen Demand (+ATU) over 5 days at 20°C	31	milligrams per litre
Suspended Solids dried at 105°C	46	milligrams per litre
Rate of discharge	-	litres per second
Volume during any period of 24 consecutive hours	-	cubic metres
Volume discharged under 'dry weather conditions' during any period of 24 consecutive hours	22.7	cubic metres

5. Adequate facilities shall be provided for the taking of samples of the effluent at: outlet from humus tanks.

The terms of this Consent will not, without the consent in writing of the person to whom this Consent is given, (or his successor), be altered before the expiration of the period ending with the Seventeenth day of December 19 84.


