### Introductory note

**This introductory note does not form a part of the notice.**

The following notice gives notice of the variation and consolidation of an environmental permit.

This variation is to:

- amend the Tier 2 Standard Rules permit SR2012 No.14 to a Tier 3 Bespoke permit for the following reason: discharge of integral site drainage channel via an engineered class one interceptor, silt trap, full retention interceptor and soakaway system.
- include additional non-hazardous waste electrical and electronic equipment (WEEE) to be accepted for storage only within a building, for direct transfer to off-site recycling / recovery facilities. Waste codes to be added include:
  - 16 02 14 - discarded equipment other than those mentioned in 16 02 09 to 16 02 13
  - 16 02 16 - components removed from discarded equipment other than those mentioned in 16 02 15
  - 20 01 36 - discarded electrical and electronic equipment other than those mentioned in 20 01 21, 20 01 23 and 20 01 35

The schedules specify the changes made to the permit.
