Notice is hereby given that Tarmac Marine and Hanson Aggregates Marine Ltd have applied to the Marine Management Organisation (MMO) and Natural Resources Wales (NRW) to undertake a regulated activity under Part 4 of the Marine and Coastal Access Act 2009.

The application is to extract aggregate from a cross-border area in the Severn Estuary and therefore, requires two marine licences - one from the MMO and one from NRW. MMO are leading on the consultation exercise on behalf of both organisations.
