This introductory note does not form a part of the notice

The following notice gives notice of the variation of an environmental permit.

This is an operator-initiated variation to increase the annual throughput from 2499 tonnes to 4999 tonnes. To implement this, changes have been made to Table S2.1 of the permit. No changes have been made to the amount of waste that the site can store on site.

In addition, we have updated the site address to reflect a change to the name and address of the larger facility that the permitted site resides on. The physical location of the site has not changed. The address of the registered office was also updated.
