Infrastructure

The infrastructure works have now been completed which has greatly improved things on site and has reduced the likelihood of any pollutions leaving site and entering ground waters. There is now only a small area at the back of the site which is unmade ground. There may be plans for this to be improved in the future but there is no waste being stored on this area. Kevin understood repairs would need to be made if any waste was to be stored on there.



The large stockpile of waste which was on site for approximately 2 years had been removed which we were pleased to see. The area underneath the stockpile was relatively intact although it was not even to the remainder of the site, causing water to pool during wet weather. Water should not be allowed to pool on site on areas where waste is to be stored and we would recommend checking the integrity of the infrastructure here before any more waste is stored here.



Exemptions

When on site we saw a large stockpile of WEEE which you advised is stored on site before being transferred to another site where it is processed. There was also a small pile of waste wood which you have told us is a by-product of the on site processes. Thank you for sending through the exemptions you have registered that allows the storage of these materials. The renewal date will be October 2017.

Environment management system

The most recent EMS we have on file for you is dated the 8th January 2013, V2. If it has been amended or updated since then can you please send us in a copy so that we can update our records.

If you could please also send us a copy of a recent internal audit that has been carried out on site so that we can see what checks are made and if applicable how issues are identified and dealt with.
