There were a number of items I wanted to discuss following up from the previous inspection.

ISO14001 Current site status

The site has not had a recent external EMS audit as they were aiming to integrate the quality, safety and environmental management systems into one. Jon Hawke stated that they have reviewed the practicality of this and at present they have decided to not have an accredited management system but they are continuing to evolve their own management system based on the framework set out under 14001.

They have decided to train all staff up to a minimum of WAMITAB level 2 and this helps maintain a high standard of permit and process understanding for the site.

Pre acceptance of wastes

This is done to a very high standard. They visit sites producing the waste and undertake pre acceptance audits. They also integrate this with a training and awareness session to enable nursing home to properly characterise the waste they produce This has proved very effective in improving the waste from nursing homes being identified and disposed of in the correct way.

Waste Destination

Waste floc is still being taken to Derwen Plant for further processing, bailing and onward shipment as an SRF material.

The hazardous waste is either sent to Tradebe or SRCL for further treatment or destruction.

Storage areas

The whole storage area is clearly labelled, well maintained and to a high standard of housekeeping.

Hazardous waste storage areas are clearly labelled and well maintained.

Spill kits are available, easily accessible and well labelled.

Process

The process line has recently been fitted with a new conveyor belt to reduce noise. At the time of the inspection the process was running and it was very quiet. The Bay has been extended for future process adaptations for the final floc.

The site has a very high standard of housekeeping and stockpiles of waste are kept to a minimum to prevent odour.
