The Site Condition Report (SCR) was received on 9th June 2020. It has been prepared to comply with the requirements of the Environmental Permitting Regulations 2016 (EPR 2016) and follows Natural Resources Wales' H5 Horizontal Guidance - Site condition reports.

The SCR complies with the requirements of EPR 2016 and is in the format recommended in H5. It is comprehensive and well supported by detailed appendices.

For future reference, there are some items that would benefit from clarification. They could be added when the document is next reviewed.

- The regime, for example the frequency and method, for non-destructive testing of tanks by external contractors should be mentioned.

- There is no mention of the procedure used to verify that IBCs are fit for purpose, this could be added to section 3.5.1.

The report is accepted.

EPR 2016 requires operators to conduct groundwater monitoring every five years and soil monitoring every ten years. The last round of monitoring was carried out in 2006 and Newport Wafer Fab should bear this in mind when their permit variation, currently in the determination process, is issued.
