Kennametal submitted a Schedule 6 Notification on 24th June 2020 informing Natural Resources Wales (NRW) that they had been unable to carry out their scheduled air emissions monitoring due to the ongoing Covid19 restrictions. They first informed NRW that they would be unable to carry out their routine monitoring on 23rd March 2020. Guidance from NRW on how to proceed was not made available to operators on the website until June 2020.

The measures described below comply with the requirements of NRW's Regulatory Decision on Monitoring and Reporting and so this non-compliance with a permit condition will not be scored.

- *"In order to minimise the significant risk to our employees and contractors from covid-19 during Q2, it was decided that emissions monitoring would not be undertaken until the covid-19 situation improved.*
- *Our activity does not and is not likely to cause environmental pollution or harm to human health as abatement equipment continues to be operational and maintained. The processes producing air emissions would not be subject to any changes that could potentially increase air emissions. One of our eight furnaces has also been out of service during this time and we were operating 5 days per week rather than 7 days, therefore our emissions will have been lower than normal.*
- *We require the expertise and equipment provided by the contracted emissions monitoring company, therefore an alternative approach to obtain data, would not be feasible.*
- *Emissions monitoring will be undertaken again in Q3 as the covid-19 situation has improved. This has been arranged for w/c 13th July."*
