Emissions from A1, A2 and A8 were not tested as the associated equipment was not running due to the Covid situation. Emissions from all the other emission points were less than their respective emission limit values (ELV).

W1, Emissions to Water

All emissions were less than their respective ELVs. One unusually high result is being retested, but this result was still less than the ELV. Testing was not possible between 3rd and 24th June as there was insufficient flow.

S1, Emissions to Sewer

All emissions were less than their respective ELVs.
