Environment officer Laoni Tye attended site with Gareth Danter-Hill on the 11th November 2016. We met with Phil Paddison (general manager) and Daniel Lewis, the site TCM. The purpose of the visit was to conduct a handover to the new regulatory officer and to gain an understanding of the sites processes. Please use the contact details below going forward:

There were no breaches recorded during the visit. The site appears to be well run, mainly receiving TV's from various civic amenity sites. All treatment processes happen inside a building on an impermeable surface with sealed drainage. LCD's are treated manually on site in a semi enclosed space to help prevent any mercury escaping. It is a closed loop system and there are mercury monitor installed to detect any unusual levels of mercury.

The panels then go down the picking line and all other components such as batteries and circuit boards are removed and stored in containers inside the building. Hazardous waste is stored separately. Glass is separated and crushed. All other non-haz waste is taken to the second permitted area of the site for storage pending recovery elsewhere. Metal is crushed and bailed ready to be sent off site for further processing.

We discussed the storage and treatment thresholds and the site agreed that they are within the limits of a waste activity and will not fall under the IED regulations.
