Natural Resources Wales NRW Officer Elysia Lovelock conducted a compliance visit to the above permitted facility on Monday 1st June 2020. Gaining access to the site via arrangements made to meet Kevin Burke at 11 A.M. at Woodmat Ltd. During the visit, the weather was fine and there was no activity at the site.

The purpose of the visit was to assess compliance with a Regulation 36 Statutory Notice issued on the 15th October 2019. The Notice required the Operator to: 'Remove from site all waste wood chip currently stored on site' and 'Operate the activity in accordance with the Fire Prevention and Mitigation Plan', by Sunday, 31st May 2020.

Following the issuing of the Notice in October 2019, to provide a visual comparison, please see the below photographs which were taken on a subsequent visit to site on 8th January 2020 to document the progress being made.



On Monday 1st June 2020 I observed the shed as seen above to be empty, as shown in the

following photograph.



Observing a remaining deposit of waste wood chip on site as seen below, which given previous suggestions, is considered to be between approximately 6 inches to 1ft in depth. However, uncertainty remains as to how much material is left.



Schedule 1 of the Regulation 36 Statutory Notice

Whilst NRW recognise that the site now poses a significantly lower level of environmental risk and appreciate the efforts that have been made to date to clear the site, the steps stipulated in Schedule 1 of the Regulation 36 Statutory Notice have not been complied with. **As such, we intend on returning to site to further assess the depth and are now considering enforcement action for the offence of failure to comply with the requirements of an enforcement notice.**

We appreciate your co-operation and assistance and trust that the issue identified and action stipulated as per this Compliance Assessment Report will be promptly addressed and actioned accordingly and look forward to continuing working with you in the future.
