Following a waste fire that took place through the night inside the waste transfer station, officers PERRY, LEE and BARRETT attended Bryn Recycling following out of hours incident officers' attendance, with the view to ensure any fire-related run off and leachate was contained.

We were met by Alun and Jen Price, and were shown the site of the fire. The remnants of waste were still smouldering, however South Wales Fire and Rescue Service had left site and had thus deemed the waste safe. Quarantined waste was stored in the central road area outside the transfer station. Assessments were made on the potential areas of fire water runoff, however no such liquid could be found and was therefore contained by the sealed drainage system.

Compliance

D2 Accidents, Emergency and Incident Planning

Permit Condition 3.6.2 You have incurred a *Category 3 breach* against criteria *D2 Accidents, Emergency and Incident Planning* for not having, and therefore not following, a robust FPMP in which prevention and mitigation measures for waste fires are listed in accordance to the relevant guidance. As per permit condition 3.6.2, Bryn Recycling shall:

"Operate the activity in accordance with the fire prevention plan, from the date of submission, unless otherwise agreed in writing by Natural Resources Wales"
