### **Waste Return Review**

A review of waste return submissions for permit EPR-AP3694FE has been completed for 2019.

Thank you for submitting all Waste Return forms for 2019. I am writing to query some information detailed in these returns.

- It has been noted that under the 'Waste Received' tab for Quarters 1,2 and 3, you have listed EWC Code 10 11 12 with the description *Glass & Stones*. Please can you confirm the origin and make up of this waste and if any testing is conducted prior to acceptance at your site.
- The site is accepting a variety of waste each quarter including soil & stones, concrete and bricks. However, only EWC Code 17 04 07 described as *Mixed Metals* are being removed from site. Can you please explain which waste fractions are directed into the WRAP Aggregate Quality Protocol compliant output (and any other Quality Protocol compliant outputs). Also, what happens to the arising contaminants derived from this process.

In addition, Permit Condition 1.1.1 of your Standard Rule permit 2008 No3, states;

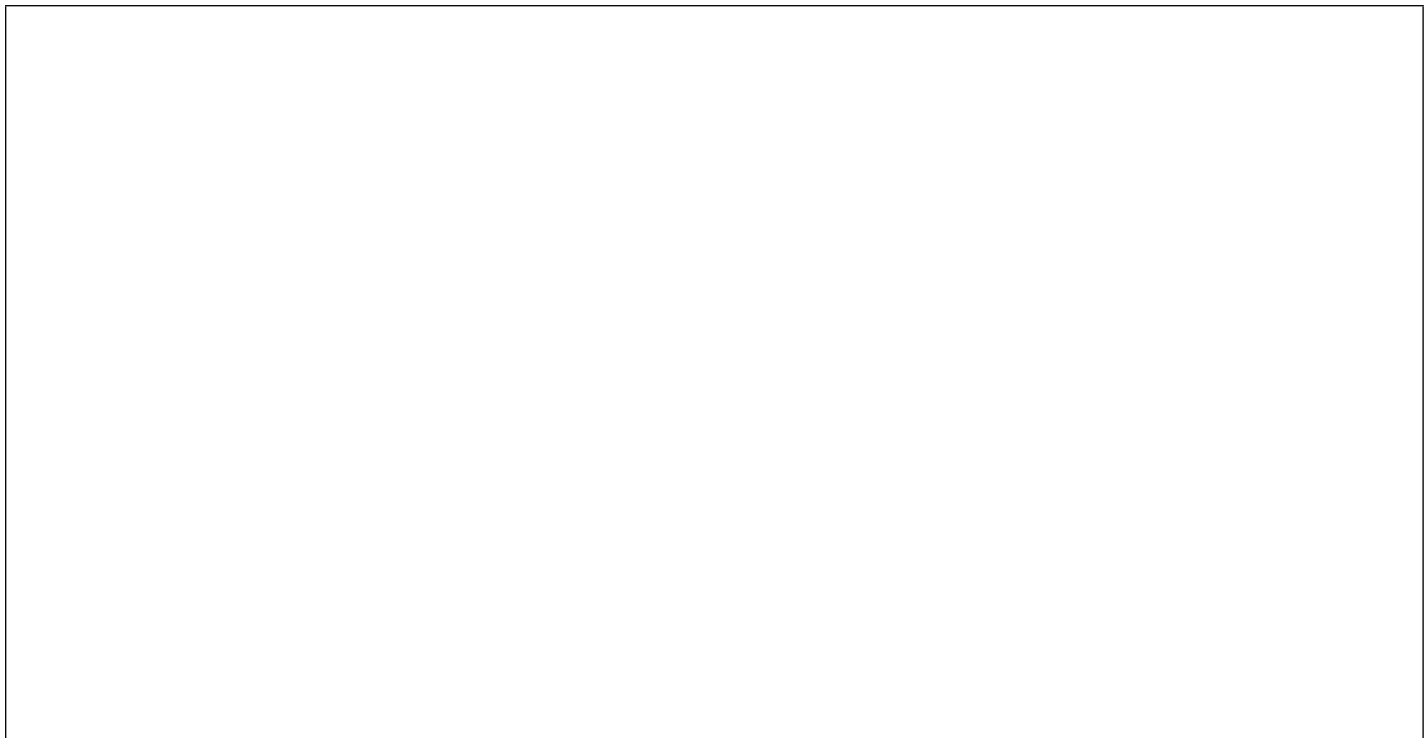
*'The operator shall manage and operate the activities:*
