The coding of waste materials is the responsibility of the waste producer and waste codes should be applied dependent on where it has arisen from in addition to how it has been treated.

If this is waste that has been produced through activities on your site, the application of a WM3 Chapter 19 EWC code 'Wastes from waste management facilities' may be more suitable.
