Hazardous Waste Regulations 2005 - Consignee Returns

In the Q2 2019 waste returns the site reported that 100 tonnes of lead acid batteries (16 06 01) were removed from site. However the corresponding **consignee** returns for this quarter reported only 1.386 tonnes of this waste was removed. There have also been no consignee returns submitted for Q1, Q3 and Q4 2019.

Hazardous Waste Consignee Returns

Hazardous waste consignee returns are required to inform Natural Resources Wales about the hazardous waste consignments that have been received, removed or disposed of at a site.

If hazardous waste has been received or disposed of at your site, you are legally required to submit a consignee return to Natural Resources Wales documenting your activities for each three month period. The return must be submitted within one month of the end of that specific quarter.
