Hazardous waste consignee returns are required to inform Natural Resources Wales about the hazardous waste consignments that have been received, removed or disposed of, at a site.

If hazardous waste has been received or disposed of at your site you are legally required to submit a consignee return to Natural Resources Wales documenting your activities (receipt, removal, disposal of hazardous waste) for each quarter.

There are reduced reporting requirements for certain wastes including, lead acid motor vehicle batteries and un-depolluted ELV's.
