This is my first visit to Kingsbridge auto parts. On arrival we were met by Scott Appleyard who accompanied us around the site.

Site walk through

At the time of the inspection there were a considerable number of cars stored on site. Of the depolluted cars inspected on the made ground there were a number with washer and antifreeze still in their There were no signs of oil spillages and all the cars were stored at a maximum of 2 high.

There were 2 cars in the depolluting bays. The bays are within the site building and at the time of the inspection the area was clean and tidy and free from oil spillages. The area was inspected and the cars were being depolluted in line with the permit conditions.

The site has recently acquired an area of land behind the depolluting building. This land is not within the permitted area. It is important that no waste is stored in this area. At the time of the inspection Cars were being stored awaiting assessment.

Technical Competence

Scott Appleyard is the technically competent manager at the site

Consignment Notes

On inspecting the consignment notes on site there were a number of errors.

The wrong premise code was used on a note leaving the site. The number was the premise code of the site where the waste was going. Kingsbridge auto parts have registered as a premise and the code is CAJ 390. This code should be used in Part A of the consignment note with a unique identifier number following that eg. CAJ 390/0001

Catalytic Convertors

The code being used for catalytic convertors is EWC 16 01 22. The code that should be used is 16 01 21* which is an absolute hazardous waste under the guidance WM3.

Consignee returns

When hazardous waste leaves your site it has to be accompanied by a consignment note. You must also send your consignee returns every quarter to NRW and the person you have treated the waste for.
