Hafryn Dyfrdwy have confirmed that following an internal error, routine sampling did not commence automatically for the newly permitted site Sugn-y-Pwll. The site was operational from 17th February 2020 and the first sample was taken on the 27th March 2020.

C4 has been assigned to this non compliance as there was a short amount of time between the start of the discharge and the first sample taken. There have been no reports of pollution to NRW regarding this site.
