This was an arranged site inspection to assess compliance with the Regulation 36 Notice issued to P Dobbins on 7th May 2020, the inspection was carried out by Senior Environment Officer Steven White who was accompanied on site by Aaron Smith. Due to the ongoing covid-19 crisis social distancing measures were adhered to during the visit

The concerns raised during the previous inspections on 13/12/19 and 11/03/20 (non-permitted waste types stored on site, no current TCM) and subsequently included in the enforcement notice were re-assessed and the site has been deemed as compliant with the enforcement notice.

There was no Waste Electrical and Electronic Equipment (WEEE) observed on site, gas cylinders and fire extinguishers had also been removed, there were a small amount of drinks cans left on site but these were being loaded into a container to be removed from site as soon as practicable. Processes have been put in place to ensure that non-permitted waste types are not accepted on site and an estimated 95% of the non-permitted wastes observed during the previous inspections have been removed.

Aaron Smith has enrolled onto the next available WAMITAB course to become the TCM for the site, proof of enrolment has been forwarded to the regulating officer. Once the course has been taken and passed can you ensure a copy of the certificate is sent to

the NRW regulating officer as soon as it has been issued.

Any alterations to the site and its operational procedures (including significant staffing changes) would have to be included in an updated Environment Management System (EMS) for the site. It is advised that the site EMS is reviewed regularly to ensure that it accurately portrays the operations on site.
