NRW received a letter from Solutia UK Ltd dated 18th May 2020. This provided an update on site activities that had either been discussed during previous site inspections or were being notified for the first time. The following comments in response to this notification is provided below:

Therminol 72

Solutia's plan to 'un-mothball' this part of the site is noted. As this facility was a previous production area it is confirmed that there is no need for a permit variation prior to recommencement of production. However, the preparatory work that is required to be completed should be used as an opportunity to improve efficiency and where appropriate also complete any upgrades such that the facility will meet the BAT standards that could be documented in the next BREF revision for the Chemicals sector.

In addition, although it is noted that there will be no new process emission points, it should be confirmed that all active release points to air were included on the recent review of release points (or should be added) as completed in response to IC34. **Action (1): Solutia.**

pDIPB

Confirm when this project is commenced. **Action (2): Solutia.**

Dequest

Confirm when the process change is implemented. **Action (3): Solutia.**

Santotar

The identification of alternative options to the use as CEMFUEL would clearly be beneficial. It is not clear from the information provided if the proposed changes to transport methodology will lead to alternative options, although it is noted more detail will be provided as the plans are developed. **Action (4): Solutia.**
