### G4 Reporting and Notification to Natural Resources Wales.

Records at Natural Resources Wales show that the site is no longer operational. However, as highlighted in a letter which was sent on the 6<sup>th</sup> January 2020 permit condition 6.1.1 requires that a summary of waste types and quantities accepted and removed from site for each financial year is produced and submitted to Natural Resources Wales within 1 month of the end of the year.

If no waste is being accepted onto the site or being sent off the site, the waste returns should indicate this i.e. nil returns.

In view of recent advice and guidance regarding waste returns a **Category 3 breach** has been applied. A warning letter has also been embedded within this CAR form.

**Action** Submit missing waste returns for 2015/16, 2016/17, 2017/18, 2018/19 and 2019/20 by 31<sup>st</sup> August 2020
