E3 - Discharge of an unauthorised material to a surface water, from a permitted discharge point or otherwise. Assessed and found no evidence of non-compliance by DCWW, criteria not breached.

Condition assessed: 2.3.1 (a) (i) the flow passed forward is equal to or greater than the overflow setting indicated due to rainfall and/or snow melt.

Third party claim submitted: 4" piece of plastic removed from sewer network in amongst rags. A 'sewer boot' was used in the downstream chamber to capture cause of blockage in order to prevent a secondary blockage downstream. Unable to confirm source of the plastic but a temporary connection without DCWW agreement / consultation had been identified into our CSO from a Jehu Group construction site welfare unit which included sections of chipboard covering chamber with the cover placed on top which could possibly have allowed third party items to enter the sewer network. Date submitted: 08/06/20. Accepted 11/06/20.
