On 20.05.2020 GE Aviation contacted NRW to inform us that a sample taken on 30th April showed a breach in the permit limits. The sample contained 18mg/l of oil and grease, whereas the permit limit is 10mg/l. GE Aviation thoroughly investigated the cause of the breach in the permit conditions but did not find any abnormalities that would explain the elevated readings.

On 7th May another sample was taken and sent to the lab. These results also showed very high concentrations of oil and grease in the sample. A re-run test was conducted on this sample which produced very different results. This is shown in the table below: -

The laboratory was unable to conduct a rerun test of the sample taken on 30th April.

GE Aviation usually use NLS to analyse the samples however, due to Covid 19, they have been unable to use this lab and therefore had sent both of these samples to a new laboratory.

Due to the discrepancies in the lab results from the sample taken 7th May and as the abnormally high results have occurred since changing to a different lab, we cannot confirm that there has been a breach in the permit conditions. Therefore, there will be no further actions.
