Celsa were required under Improvement condition 5 (IC5) to submit a revised dust management plan. This has been received by NRW and assessed as meeting the requirements of IC5.

IC5 was necessary due to the site permit being varied (V009) to include asphalt processing and slag processing operations to the original activities.

The root guidance for dust management plans comes from EA M17 which formed the basis of IC5 and held the following requirements. The site dust management plan received 1st July 2020 was evaluated against each point with comments as below;

Methods of PM <sub>10</sub> and/or dust emission monitoring	Two methods are to be used, visual, and ambient monitoring through frisbee gauges, and sticky pads.
Confirmation of location of monitoring devices.	2 points are designated on the site plan. One upwind and one down wind of the prevailing wind at the site. Both are situated on the outside site fence line. This meets the requirements of M17 guidance.
A methodology to demonstrate that abatement techniques have been effective at minimising fugitive emissions escaping the site boundary.	Results are to be evaluated during internal audits.
Action and review levels with an overriding aim to ensure that PM <sub>10</sub> and TSP emissions from the facility are eliminated or minimised.	Action and review levels are included in the plan. M17 guidance at section 5.2.2 carries an outline 200 mg m <sup>-2</sup> day as a UK ambient average where actions above this level should be taken. This has been adopted by site.
Planned initial duration of monitoring and definition of the conditions under which sufficient information will have been collected, for monitoring to be reduced or ceased.	A six month monitoring period is required by the site permit and has been adopted.
