Received the initial report on the 20.06.20 regarding a blockage causing an in permitted discharge from CSO asset number 71704, blockage was caused by fat and rags accumulating in the CSO during storm conditions the previous two days. Blockage prevented the CSO to return to normal duties after the storm like conditions had ceased. Effluent that was dilute and screened still discharged until 20.06.20 roughly 7 hours but showed no impact.

DCWW submitted a no impact claim

Under 16_02 guidance of 'no impact' I accept the claim given by DCWW as:

Evidence of 'no impact'

Photographs provided by DCWW show no discolouration, sediment materials entering and the absence of a visible plume in the watercourse

Quality of effluent described in no impact claim and photographed by DCWW suggests effluent diluted by rainfall with no materials present

However please note if unpermitted discharges continue to occur in this area. These may not qualify as no impact claim in the future, require DCWW to undertake investigatory and remedial measures and subject to enforcement action.
