

THIS AGREEMENT is made the \_\_\_\_\_ day of \_\_\_\_\_  
BETWEEN the WELSH WATER AUTHORITY whose principal office is situate  
at Cambrian Way Brecon in the County of Powys acting by HUW PROTHERO the Divisional  
Manager of the West Wales Division duly authorised in that behalf (hereinafter called  
"the Authority") of the one part and THOMAS REES LLEWELLYN LEWIS of Scollock West,  
Ambleston Haverfordwest Dyfed

(hereinafter called "the Licence Holder") of the other part

WHEREAS

1. The Licence Holder is the holder of a licence to abstract water  
(hereinafter called "the Licence"), granted by the Authority under the  
Water Resources Act 1963 and having the following Serial Number 22/61/2/34/5  
and dated 19th August 1980.
2. In accordance with the provisions of the Licence the water is to be  
used on land of which the Licence Holder is the occupier (hereinafter  
called "the relevant land") and the purposes for which water abstracted  
in pursuance of the Licence is to be used consist of or include spray  
irrigation
3. The Licence Holder has applied to the Authority to make an agreement  
with him under Section 63 of the Water Resources Act 1963 (hereinafter  
called "the Act") as amended by the Water Act 1973 in respect of the  
charges payable to the Authority in relation to the Licence and the  
Authority have agreed thereto in manner hereinafter appearing

NOW IT IS HEREBY AGREED as follows:

1. IN this Agreement:-

"year" means the period commencing on the 1st day of April and  
terminating on the next following 31st day of March

"the charges scheme" means the charges scheme of the Authority under  
Section 31 of the Water Act 1973 and for the time being in force

"charges" means charges payable to the Authority under the terms  
of the charges scheme

2. DURING the period for which this Agreement is in force charges shall be payable by the Licence Holder to the Authority in respect of the Licence for the time being in force in so far as the Licence relates to water authorised to be abstracted and used for spray irrigation on the relevant land as follows that is to say:-

(a) basic charges at the rate of 25 per centum of the rate or rates applicable under the charges scheme calculated by reference to the quantity of water (hereinafter called "the authorised quantity") authorised to be so abstracted and used from time to time in pursuance of the Licence; and

(b) supplementary charges at the rate of 75 per centum of the rate or rates applicable under the charges scheme calculated by reference to the quantity of water (hereinafter called "the quantity abstracted") which is measured or assessed as being abstracted from time to time by or on behalf of the Licence Holder from the source of supply to which the Licence relates for use on the relevant land

3. (1) FOR the purposes of this Agreement the quantity abstracted shall be assessed in accordance with the following arrangements:-

(a) By 1st April in each year the Licence Holder will specify and return to the Authority on a form to be supplied by the Authority details of the equipment proposed to be used by the Licence Holder for spray irrigation purposes during the ensuing 12 months and if any subsequent change is made in the equipment used by the Licence Holder he must inform the Authority forthwith giving details of the new equipment

- (b) The Licence Holder will keep a daily record of the operation of the equipment for spray irrigation purposes and shall not later than 14th November in each year submit to the Authority a copy of the daily records for the immediately preceeding period of abstraction authorised by the Licence (hereinafter called "the abstraction period").
  - (c) From the details of the equipment supplied by the Licence Holder under(1)(a)supra the Authority will calculate the average hourly output of the equipment and on receipt of the daily records the Authority will assess the total quantity of water abstracted by the Licence Holder for spray irrigation purposes during the abstraction period.
  - (d) The daily record of hours of operation of the equipment shall be kept available for inspection by any officer of the Authority at all reasonable times
- (2) IN the event of the Licence Holder being in default as respects compliance with any of the arrangements specified in paragraph (1) of this clause in relation to the Licence and failing within fourteen days after being served by the Authority with a notice requiring him to rectify such default then for the year in the course of which such default occurs charges shall be payable at the rate for the time being applicable under the charges scheme
4. THE charges payable by the Licence Holder under this Agreement shall become due and payable as follows
- (a) in respect of the authorised quantity on 30th April in each year
  - (b) in respect of the quantity abstracted on 31st December in each year provided that if the charge due in respect of

the quantity abstracted is more than £100 then such charges shall be payable in two equal instalments due respectively on 31st December and 31st March

5. IN any case where the authorised abstraction is from a reservoir controlled by the Licence Holder but the Licence Holder is not entitled to the benefit of any winter seasonal weighting under the terms of the charges scheme the Authority may in its absolute discretion afford the Licence Holder a seasonal weighting equivalent to the winter weighting in the charges scheme Provided always that the Authority is satisfied that (i) the whole of the inflow during the "non-winter" months April to October inclusive is effectively released from the reservoir thereby enabling the natural flow in the river to be maintained and (ii) a significant part of the inflow is specified in the licence to be released from the reservoir during the "winter months" November to March inclusive and also provided that where the whole of inflow during the "non-winter" months April to October inclusive is effectively released from the reservoir thereby enabling the natural flow in the river to be maintained, but a significant part of the inflow cannot be released during the "winter" months November to March, the Authority may in its absolute discretion, afford the Licence Holder a weighting intermediate between the factor for winter seasonal weighting as indicated in the charges scheme for the spraying season concerned and the weighting factor one.
6. THIS Agreement shall take effect from the date of the Licence and shall remain in force for a period of five years following the 1st day of April next after the date hereof unless previously terminated by one or other of the following events (as provided in sub-sections (5) and (6) of Section 63 of the Act) namely:-
- (a) the Licence expires or is revoked

(b) the Licence Holder ceases to be the occupier of the relevant land or if he has previously ceased to be the occupier of a part or parts of that land ceases to be the occupier of the remainder of it

(c) this Agreement is sought to be terminated on the application of the Licence Holder to the Authority and the Authority is satisfied that by reason of any change of circumstances since this Agreement was made it ought to be terminated (in which case the Authority may terminate this Agreement either unconditionally or subject to such conditions whether as to any payment to be made by the Licence Holder or otherwise as the Authority and the Licence Holder may agree)

PROVIDED that the termination of this Agreement under this clause shall be without prejudice to any remedy of the Authority as to the recovery of charges due and payable prior to such termination in accordance with this Agreement or otherwise
