Schedule

1. Submit a manure management plan.
2. Update your drainage plan to show where the ranging areas are located and where the runoff from these ranging areas would go.
3. Update the drainage plan to include the existing drainage already in place for the existing sheds.
4. State the capacities of both the clean and dirty water tanks.
5. Your submitted ammonia modelling report shows that process contributions from the poultry unit to several nearby ancient woodlands don't screen out at detailed modelling.

Your consultant has recommended that, if available, to compensate for possible detrimental effects on the nearby ancient woodlands, that land of at least a similar area to the exceedance of 100% of the critical level is set aside for nature conservation. Alternatively, or additionally, buffer zones and corridors could be set up around and between the ancient woodlands.

Please demonstrate how you have considered this recommendation, and what was your conclusions.
