As discussed with you on site, managers are required to renew their WATIMAB certificates this month. Once you receive these certificates they will need to be sent the NRW.

While on site you discussed your plans to move the site to a nearby, larger site. NRW will be available to assist with any advice and guidance required to make these changes.
