4. Details of our assessment

Quarterly reporting of emissions – Q1 (Jan – Mar 2020) and Q2 (Apr – Jun 2020)

Monitoring for emissions at points W1 and the Effluent Plant Discharge required by condition 3.5.1 was undertaken and the results reported within the timescales required by condition 4.2.3 of the permit.

Monitoring of emissions were submitted on 08/04/2020 for Q1 (Jan – Mar 2020) and 17/07/2020 for Q2 (Apr – Jun 2020).

All results for the emission points were within the emission limit values specified by condition 3.1.2.

Emissions to Air

Part A & B notifications were submitted on 08/07/2020 following compliance testing at emission point A21 on 05/02/2020.

Verbal notification of a likely breach of VOC above the 20mg/m³ limit was reported to NRW on 06/02/20. Average result during test was found to be 28.5mg/m³, with uncertainty of 1.9mg/m³. NRW advised Tata to wait for the formal report to determine if the initial result was above the limit.

Due to Covid-19 and the furlough of testing staff, the draft report was not available until 03/07/20. Inspections at the end of February / beginning of March indicated remedial repairs were required. Again, due to Covid-19 restrictions, works to repair the issue were delayed as staff were furloughed.

The draft report indicates a breach of 28.5mg/m³ VOC did occur. Various actions have been put in place to remediate the issue with retesting scheduled for after the works have been completed.

The VOC result of 28.5mg/m³ above the 20mg/m³ limit is a category C3 non-compliance scored under permit condition 3.1.2.
