4. Details of our assessment

Annual monitoring returns for 2019

Requirements: Condition 4.2.2 requires that a report on the performance of activities over the previous year shall be submitted by 31st January each year.

Findings: Reporting forms for water and energy usage, and raw materials were received on 17/02/2020 in accordance with an informal agreement made with NRW in 2014/15 requiring submission of data by 21st February each year.

The production volume of 20,645 tonnes for 2019 was down compared to 2018 (22,614tonnes).

Raw material usage for 2019 was 29,092 tonnes, up on the 26,339 tonnes used for 2018 and water usage of 8.52m³/t in 2019 is up compared to 8.04m³/t in 2018 despite reduced production.

Energy usage for 2019 of 2.43MW/t was similar to 2018 (2.41MWh/t).
