Environment officers Nessa Dearle and Kelly Sherratt visited Llantrisant Community Recycling Centre on the 15/06/2017 to complete a routine site inspection. The weather was warm and dry and waste was being accepted at the time of the visit.

Thank you for showing us around site and explaining the activities. The site appeared well managed at the time of the inspection, however one breach of the permit was recorded. This breach is outlined below.

C4 – Storage, handling, labelling and segregation. Category 3 breach, Condition 2.4.1 states that the storage (including temporary storage) and treatment of WEEE shall be carried out in accordance with the technical requirements of Annex VIII of the WEEE Directive.

During our site visit, it was noted that WEEE was being stored outdoors in containers without a weatherproof covering. The WEEE Directive outlines that that WEEE waste should be stored with a weatherproof covering, this preserves the quality of the materials.

Action

To comply with your permit you are required to provide a weatherproof covering for all WEEE materials stored on site. Other containers seen on site had weatherproof coverings, these containers would be appropriate for WEEE storage. We request that appropriate storage conditions be put in place for WEEE within 4 weeks of receipt of this form. You will also need to notify myself as the regulatory officer of any improvement works.

While on site, paperwork relevant to the permit was checked including the latest environmental management system (EMS). However, an up to date certificate of technical competency was not found. Please can the updated version be sent to the NRW via email or post as soon as possible. Please get in contact if you have any queries relating to this form, my details can be found below.
