The purpose of today's visit was to assess progress in relation to the regulation 36 enforcement notice served on the operator requiring the removal and treatment of all stockpiled oversized glass and funnel glass currently stored outside of unit 8 contrary to the permit conditions. The deadline of this notice is 18th November 2017

Present on site was Rhys Ellis, Regulatory Officer Natural Resources Wales (NRW) and Kevin Lyttel (Display Recycling Ltd).

There was a considerable amount of material stored outside and the operator was reminded of the deadlines of the notice. It was agreed that the operator would keep Natural Resources Wales updated on progress. The operator believed that the required deadline would be achieved.

Recent noise complaints were discussed on site and operator advised that the reversing bleeper issue had now been resolved.

Code B reference 00180 was issued to the operator during the visit.

Waste 'Sweepings'

Previous compliance assessment form reference CAR_NRW0031811 issued to the operator related to issues regarding contamination of glass within the waste 'sweepings' and associated Duty of Care.

Operator advised that additional measures have been put in place to avoid contamination of sweepings with hazardous material (glass etc) on line 4. There are also planned improvement of an additional sieve for line 3.

The operator deem the sweepings non-hazardous. As discussed during the visit reference should be made by the operator to Waste Classification and Assessment - Technical Guidance WM3 , which should be used by sites that produce, manage or regulate waste in determining if a waste is hazardous or not.
