Thank you for taking the time to show Environment officers Nessa Dearle and Laoni Tye around your site on the 28th of July. The weather was dry and mild at the time of the inspection and waste was not being accepted on site.

The site appeared well managed at the time of inspection and no permit breaches were recorded from the visit.

Notes

While on site we noted that the waste storage area appeared to be on a non-impermeable tarmac surface. However, we were later informed that there was a concrete impermeable surface under the tarmac, in which case this is considered a suitable impermeable surface.

While on site it was confirmed that the site currently only accepts asbestos waste. Hazardous waste is permitted to be stored as it currently is on site, in lockable containers outdoors. However, in the future should the site start to accept other forms of non-hazardous waste included in the permit this would be required to be stored indoors and handled inside the building.

Thank you for showing us the updated Certificate of Continued Competency for the site operator. Please send an electronic copy, so that the updated version can be added to our system. While on site we were advised that the Environmental Management System/working plan is in the process of being updated. Once this is completed please send a copy of the system to NRW.
