We met Christopher Edwards and Jack Alderdice on site.

There was a lot of moss growing on the filter bed media (see attached photos) which could reduce the amount of treatment of the effluent in the filter bed. Please can you arrange for the growth to be cleaned off and then cleaned on a regular basis to prevent it from building up to this level in the future.

The bearings on the tipping trays on the northern side of the works appeared to have failed. This was causing an uneven distribution of effluent onto the filter bed media below. Please can you arrange for the bearings to be repaired by 28.02.18 and let neil.griffiths@cyfoethnaturiolcymru.gov.uk know when this has been done.

Both of the issues referred to above are breaches of permit condition 4 *'in particular the works shall be maintained properly'*.

We also looked at the discharge into the receiving watercourse and it looked very clear.
