Incident response following report of fish kill on the Afon Clywedog.

Incident was caused by a discharge of settled storm sewage via the storm outlet at Five Fords STW. Work was been carried out on the final effluent chamber which required the inlet to be diverted to storm tanks for the time the clean-out was taking place. During this phase the storm tanks filled unevenly and discharged out of the storm discharge point and into the afon Clywedog resulting in a major fish kill.

Investigations are ongoing.
