Dear Alex,

Horizon are currently in the process of fully demobilising from site due to the new power station being suspended by Hitachi. As a result we will no longer be able to discharge to ground on their land. There is currently an agreement with Natural Resources Wales (NRW) that contractors working on Horizon land are able to discharge to land under this agreement. This agreement will cease to exist from 31st March 2019. I have spoken to NRW and they will not honour the agreement with us and have stated they expect us to apply for a water discharge permit.

I now need to apply for another water discharge permit for the Wylfa project on what was originally Horizon Land. The permit will be exactly the same as described below but for work in a different location.

I have placed your name on the permit and I am happy with the permit details and management of water on the project. Please can you confirm you are happy?

Dear Alex,

Please could you authorise your name to be used on a water discharge permit application for Wylfa 132kV Cable Project.

We need to apply for the permit as we have surpassed our 3 month period of being able to discharge water from our excavations and the project is taking longer than initially expected.

The application is for a temporary discharge consent for untreated surface water to be discharged to ground to facilitate the construction/diversion of oil filled cables for the new Wylfa Power Station.

The discharge is rainfall which has entered our excavations/work areas and requires discharge to surrounding land to facilitate us in completing our works. Water shall be pumped using a four-inch pump to the surrounding fields as identified on the Water Discharge Drawing. Controls are in place to monitor this discharge.

I have attached form Part F2 which will have your name on and by signing this you agree that to the best of your knowledge the information is accurate – I am happy with what has been submitted to NRW.
