Tony Bruten carried out a routine inspection on Tuesday 28th July 2020. I have not breached the unit on any permit conditions, however I have identified a problem with the old slurry lagoon which is currently used to collect the washing water from the site.

The lagoon is the old slurry lagoon remaining from the previous farm and although a form of reed bed system is operating this is not compliant with current and future legislation. There is seepage of slurry liquid from the lagoon into the adjacent water course and is a potential pollution. NRW will be carrying out water sampling in the future to assess the state of the watercourse.

It has been agreed with Ian Williams that a new sealed collection tank will be installed on site adjacent to the concreted pad to collect washing out water which will be contained within the tank before sucking out and spreading to fields. It has been agreed that this tank will be installed before 31st March 2021.

All clean surface water can be discharged straight to the watercourse.

The old slurry lagoon will need to be cleaned up and decommissioned. This can be done following completion of the installation of the new tank. Prior to clearing up the slurry in the old lagoon, NRW should be consulted to ensure no pollution is caused to the watercourse during this operation.

NRW will continue to monitor the new installation and are available to be consulted with at any stage.
