Tony Bruten carried out a routine permit inspection of the Merrystream Poultry unit. There were no breaches recorded.

A number of issues were discussed during the visit.

1. The NRW contact number on the identification notice was missing a 0 and should read 0300 065 3000.

2. There had been a previous complaint from a neighbour regarding noise during thinning and emptying of sheds by Avara. The owners have consulted with Avara and requested they thin during more sociable times not during the night and there is a letter of communication from Avara on the NRW system acknowledging this. It was suggested and agreed that maybe if the complainant was willing the site operator (Julian Williams) would text the person concerned to notify them a day or two before thinning or emptying procedures are done. Tony Bruten NRW to communicate with complainant to see if he agrees to his number being passed to the site.

Tony Bruten will continue to liaise with the complainant and the site.
