4. Details of our assessment

Forms W1, Emissions to Water and S1, Emissions to Sewer for July to September 2020, were received on 2nd October 2020.

The forms are accepted.

W1, Emissions to Water

All parameters were within their respective emission limit value (ELV).

S1, Emissions to Sewer

pH was within its specified limits.

The aluminium discharge on the 18th July 2020 was 5.5mg/L, the ELV is 2mg/L. A Schedule 5 Notification was received by Natural Resources Wales (NRW) on 3rd August 2020 to inform them of this permit breach. This was more than the specified 24 hour notification period. Several other non-compliances were revealed when the cause of this breach of ELV was investigated by AIUK which are being or have been addressed by the operator. They are detailed in CAR_NRW0036841. NRW are confident that AIUK are determined to remedy any problems and that these improvements will be in place by the beginning of 2021.
