All emissions were less than their respective emission limit values (ELV).

W1, Emissions to Water

It was not possible to test emissions to water during this quarter because there was insufficient water in the interceptor to take a sample. This was due to the dry weather and one period when the interceptor was being cleaned.

S1, Emissions to Sewer

All emissions were less than their respective ELVs.
