3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

Sims submitted a Schedule 5 Notification in respect of foam exceedance from sampling undertaken on 29th July, 2020 and reported to Sims on 16th August, 2020. The Schedule 5 Notification was received on 2nd September, 2020, which is more than 24 hours after Sims became aware of the permit breach.

ACTION: NRW must be informed of any breach of a permit condition within the time specified in Schedule 5. Sims should ensure that systems are in place to comply with permit condition 4.3 Notifications.

Sims have investigated the cause of the exceedance of the limit for foam remaining on the granulated metal after processing in metal plant line 1. No operational issues have been identified, however, a further investigation into the cause of the exceedance is requested and Sims should submit a report of the findings to NRW by 30th October, 2020.
