4. Details of our assessment

On the 28th August 2020, Morganite Electrical Carbon Limited Notified Natural Resources Wales (NRW) via email of an emission breach at the site during their monitoring. It was then followed up by a phone call to discuss the breaches.

The following text below outlines the notification received from Morganite.

Emission point A27 (Total Particulate) - measured a value of 25.3mg/m^3 with an uncertainty of 1.5mg/m^3 at 13:00-14:00 on the 28/07/2020. Permitted limit 10mg/m^3

Emission point A28 (Total Particulate) - measured a value of 26.6mg/m^3 with an uncertainty of 1.6mg/m^3 at 14:33-15:34 on the 29/07/2020. Permitted limit 10mg/m^3

Two further notification were submitted to NRW to notify on approach to limits. Details follow below.

A28 (Ace Kiln 3 & 4) and A61 (Ace Kiln 5 & 6). The date and time for the above breaches were as follows:

Emission Point A28 (NO_x) - measured 152.1mg/m^3 (uncertainty of 40mg/m^3)

Emission Point A61 (Total Particulate) - measured 10.2mg/m^3 (uncertainty of 0.74mg/m^3)

The measured value is within the permitted limits with uncertainty considered.

The Operator, after discovering the breaches on site, reviewed the kiln monitoring program data and it shows that there was no apparent issue with the programme running. It also showed that all the parameters were within the normal limits.

They will look into this during the monitoring for Q4 later in 2020.
