2020 Data review (for information only)

Since October 2018 problems with a bacterial film that looks like an oil sheen have been noted at the Coffe Dam outfall (Activity reference - A4 Coffe Dam in Schedule 3 of the permit), likely to do with the stagnant water. Qualitative and quantitative analyses of the samples at this point has been undertaken since 2019.

Please find table below detailing the sample results over this year.

As seen in the table, in October 2019 and January 2020, following visual confirmation of oil by our sampler, trace amounts of oil were found in the quantitative analysis. These volumes are negligible.
