Solutia UK Ltd. provided NRW with a Schedule 5 Part A notification on 9th June 2020 and the follow up Part B on 17th July 2020.

It was reported that there had been a leak of T66 heat transfer fluid from a transfer line. This had been contained and spill granules used to clean up. There had been no loss to ground or the site effluent system. Upon subsequent investigation it was determined that the transfer line had corroded where it passed through a wall. An estimated total of 30kg had been lost from the line.

Following identification of the cause and to prevent a recurrence Solutia planned to conduct a site survey to identify any other points where pipework passes through walls and check for corrosion.

Action (1): Solutia to confirm completion of the site survey and provide a summary report by 31st August 2020.

NRW have not assigned a non-compliance in response to this incident for the following reasons;

- Solutia provided NRW with a timely and detailed response to the loss
- The loss was minimal, was identified promptly and there was no loss to ground. All spillage material was recovered.
- There was an effective and timely follow up to the incident and measures were implemented to minimise the risk of a recurrence.
